- **24-Hour Curfew Reminder** – It is critical that Saudi Aramco employees adhere to the curfew times of their home locations. At present, there is a 24-hour daily curfew for the cities of Riyadh, Makkah, Madinah, Tabuk, Dammam, Dhahran and Hofuf, and also the districts of Jiddah, Taif, Qatif, and Khobar, until further notice. The directive applies to Saudi Aramco communities in the above listed areas. All people must be in their homes 24 hours per day, with the exception of leaving for absolutely necessary reasons such as purchasing food and medical care between 6 a.m. and 3 p.m. Please note that vehicle transportation is limited to one person in addition to the driver. Employees must remain within their community. Outdoor recreational activities such as walking/jogging and cycling are not allowed. Employees who have obtained the necessary curfew exemption documentation from their organizations may travel between work and home as required.
- **National Curfew Reminder** – Excluding the specific areas listed above that are under the 24-hour daily curfew, the national curfew for all other areas is from 3 p.m. to 6 a.m. Employees should check with their supervisor to understand any impact and specific work instructions.
